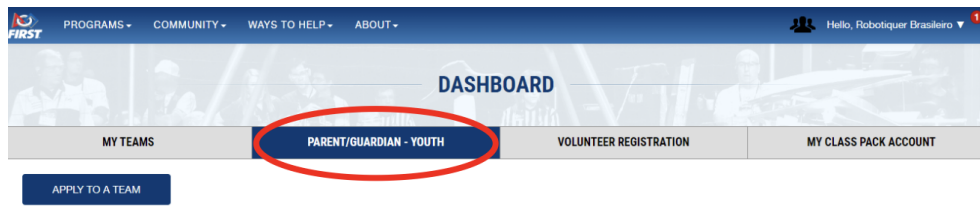

1. Acesse a conta de seu filho.
2. Acesse a aba "Parent/Guardian".



No Parent/Guardian

You are under 18 years old and require a Parent or Legal Guardian to manage the legal requirements on your behalf such as the Consent & Release form.

Here you can invite and see the individual Parent or Legal Guardian that would then be associated with your FIRST® account.

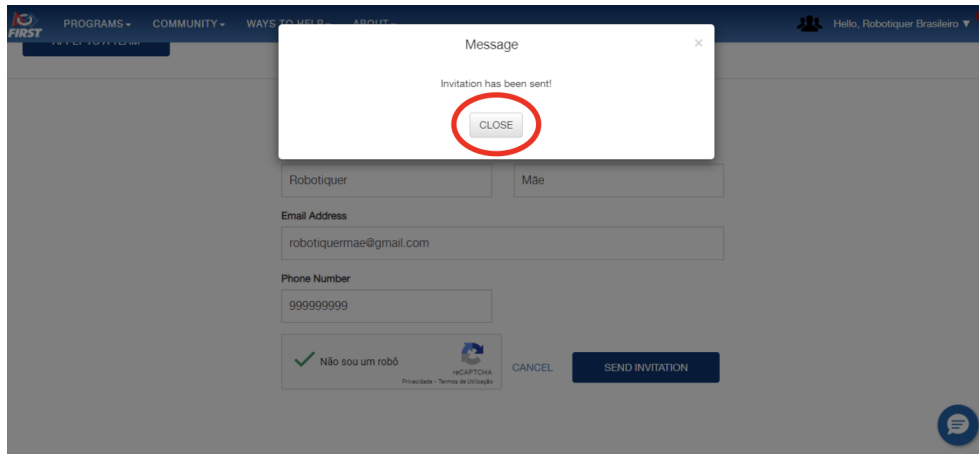

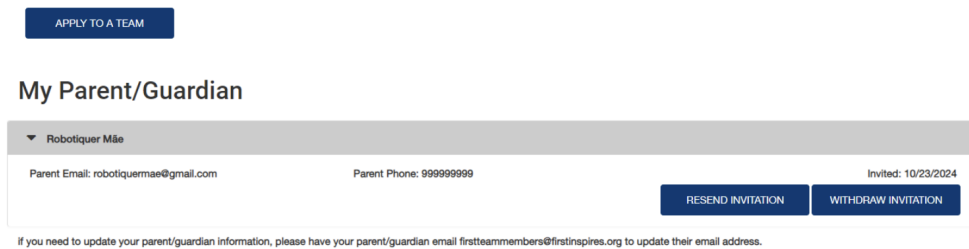
3. Clique em "invite parent/guardian"

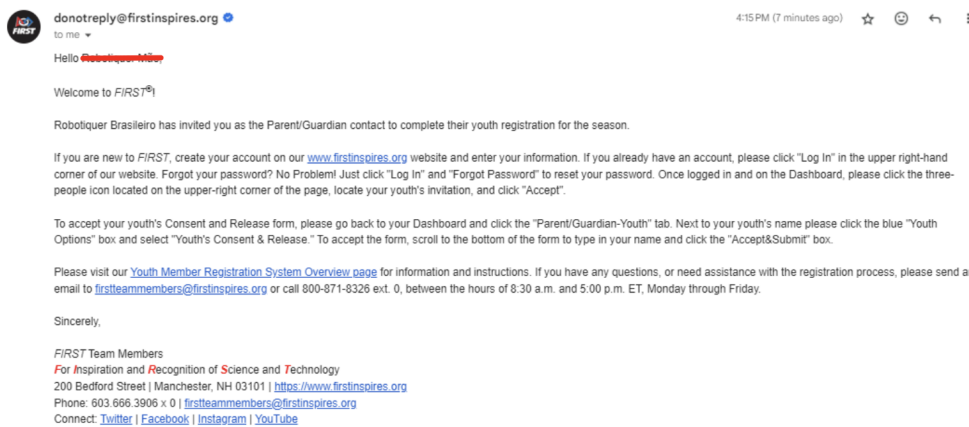
4. Preencha com seus dados e feche a mensagem.



5. Confirme na conta se seu pedido foi enviado.

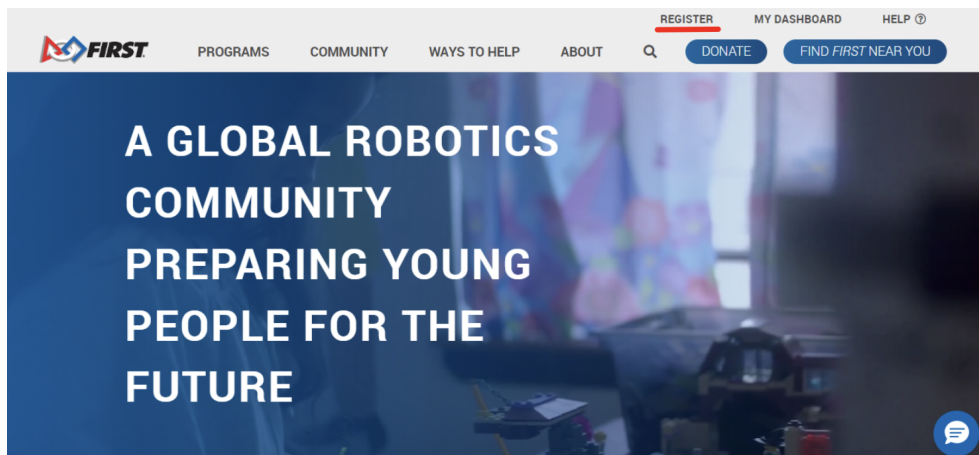


6. O responsável deve receber em seu email, usado antes, uma mensagem da FIRST.

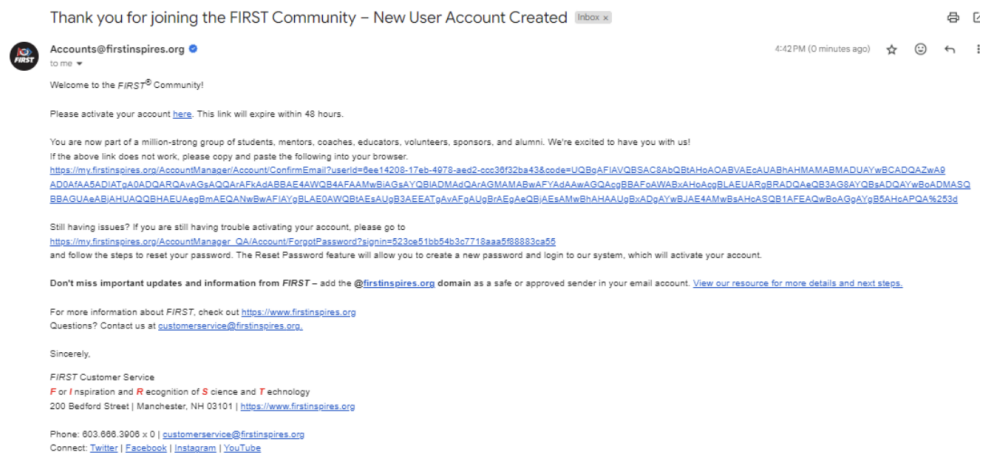

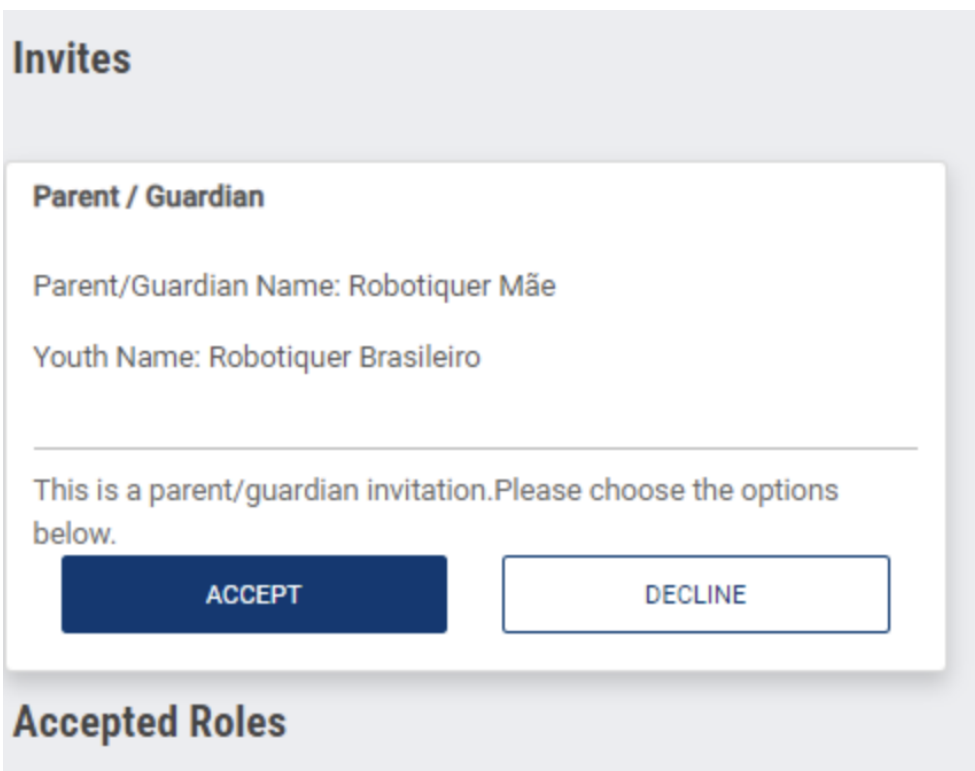
